

Fundraising Agreement

1. I AM 18 YEARS OF AGE AND HAVE MADE A FIRM COMMITMENT TO GO WITH "DALLAS SOY CANDLES" FOR OUR FUNDRAISING EVENT. I AM NOT STILL CONSIDERING ANOTHER COMPANY OR PLANNING TO RECEIVE BROCHURES AND ORDER FORMS FROM ANOTHER COMPANY.

2. ALL OFFICERS AND MEMBERS HAVE APPROVED THIS FUNDRAISER AND TWO SIGNATURES FOR OUR ORGANIZATION/GROUP/TEAM HAVE BEEN PROVIDED. WE ARE READY TO START SELLING.

3. I AM READY TO SCHEDULE A KICK-OFF DATE FOR THE FUNDRAISER AND A DATE TO HAVE ALL ORDERS TURNED BACK INTO "DALLAS SOY CANDLES."

4. I UNDERSTAND THAT IF THE ORGANIZATION FAILS TO CONDUCT THE FUNDRAISER AFTER COMPLETING THE AGREEMENT FORM AND PACKETS HAVE BEEN SHIPPED THAT THE ORGANIZATION WILL REIMBURSE DALLAS SOY CANDLES FOR THE COST OF THE PACKETS AND SHIPPING CHARGES.

5. WHEN MAKING PAYMENT FOR THE FUNDRAISER, I UNDERSTAND THAT "DALLAS SOY CANDLES" WILL ONLY ACCEPT CASH, MASTERCARD, VISA OR CHECKS FROM THE FUNDRAISING ORGANIZATION. (NO PERSONAL CHECKS WILL BE ACCEPTED FROM SELLERS OR PURCHASERS.) I ALSO AGREE TO COVER EXPENSES INCURRED BY "DALLAS SOY CANDLES" IN THE EVENT OF A RETURNED CHECK AND / OR THE FUNDRAISER IS NOT RUN. YOU WILL BE INVOICED VIA PAYPAL UPON RECEIPT OF THE ORDER RECEIVED FROM YOU.

6. A MINIMUM OF 100 CANDLES MUST BE SOLD PER FUNDRAISER. FREE SHIPPING WITH AN ORDER OF AT LEAST 500 CANDLES. THE ORGANIZATION WILL EARN 50% ON THEIR CANDLE ORDER PROVIDED THEY MEET THE MINIMUM 100 CANDLE REQUIREMENT.

7. NOTIFICATION OF ANY MISSING CANDLES OR DAMAGES DUE TO SHIPPING SHALL BE MADE WITHIN 10 DAYS OF THE DATE THAT YOU RECEIVE YOUR ORDER.

8. ALL ORDERS WILL BE SHIPPED WITHIN 14 TO 21 BUSINESS DAYS FROM THE DATE OF PAYMENT AND ORDER PLACEMENT.

9. ONCE PACKETS HAVE BEEN SHIPPED TO FUNDRAISING ORGANIZATION THE FUNDRAISER WILL CONDUCT THE FUNDRAISER WITHIN THE TIME ALLOCATED. IF FUNDRAISER IS NOT CONDUCTED, THE ORGANIZATION AGREES TO REIMBURSE DALLAS SOY CANDLES FOR THE COST OF THE PACKETS AND SHIPPING COSTS WITHIN 15 DAYS BEING INVOICED BY DALLAS SOY CANDLES.
